



Who is RAVEN?

For more than a decade, RAVEN has partnered with Indigenous Nations to raise legal defence funds to support precedent setting legal actions aimed at saving and healing their traditions, lands and waters. Tangible impacts on the ground result from RAVEN's partnerships with various Nations, through legal victories that have stopped pipelines, protected sacred water from open pit mines, and preserved pristine ecosystems, and created better laws. How to make a gift

There are many ways to contribute a generational gift. After you have taken care of your family and friends you may consider one of the following ways to leave a legacy to RAVEN:



Bequests

Make a bequest: A charitable bequest is a gift made through your will or living trusts. Gifts can be designated to a specific campaign, or you can direct your gift to the Friends of RAVEN Foundation. Friends of RAVEN Foundation exists solely to support RAVEN's mission and mandate.



Securities

Donate securities directly to RAVEN; this will allow your estate to avoid paying the capital gains tax on your investments.



RRSP/RRIF's

Name RAVEN as the beneficiary of any portion of your Registered Retirement Savings Plan (RRSP) or Registered Retirement Income Fund (RRIF)



Life Insurance Policy

Designate RAVEN as an owner and/or beneficiary of a new or existing policy.
