PULL TOGETHER - Stop Kinder Morgan: RAVEN raised and distributed \$591,000+ to 4 First Nations in British Columbia that launched legal action in 2017 to stop the Kinder Morgan Trans Mountain pipeline expansion project (TMEX). The project threatens the wildlife, communities and economy of BC. The project would also increase tanker traffic by 400%, cutting through critical orca habitat and threatening the waters around Vancouver, the Gulf and San Juan Islands and Strait of Juan de Fuca. In 2017, the Nations presented their case in Federal Court in October. No judgment was delivered.

PETRONAS - Wild for Salmon: RAVEN raised and distributed \$191,000+ to four Aboriginal groups along the Skeena and Nass Rivers that were challenging the proposed Petronas LNG facility in court. RAVEN supported the Tsimshian tribe of Gitwilgyoots, the Gitanyow Hereditary Chiefs, the Gitxan House of Luutkudzliiwus, and the Gitxan House of Gwininitxw to stop Petronas' LNG pipeline and export terminal in the pristine salmon habitats that have sustained indigenous families for millennia. By the end of the year, Petronas withdrew from the project and the campaign was closed to the satisfaction of the four nations.

**1. HEILTSUK - STAND WITH COAST HEROES (Expenses - \$78,091)**

One year after the Heiltsuk suffered the devastating impact of the Nathan E. Stewart spill in their territory, RAVEN stepped in and began fundraising towards a legal challenge to Canada and Kirby Corporation. Aimed at recompensing the Heiltsuk for their loss of fisheries, traditional foods and cultural sites, the suit has the potential to strengthen marine safety regulations and bring critical changes to Canada's oil spill response regime.

**2. LAKE BABINE (Expenses - \$3,488)**

RAVEN raised funds to cover Lake Babine's costs in responding to Pacific Booker Mineral's reconsideration submissions for the proposed Morrison Mine.

**3. PROTECT THE PEEL (Expenses - \$66,204)**

In a unanimous decision, the Supreme Court of Canada upheld the plan to protect the majority of the Peel Watershed in northern Yukon. The Supreme Court decision means the Yukon Government must protect 70% of the Peel Watershed from industrial development, including mining and fossil fuel extraction. This exquisite and pristine land will be stewarded by a coalition led by Indigenous Peoples, thanks to the support of RAVEN and our allies.

**4. TSILHQOT'IN VS TASEKO MINES - SAVE FISH LAKE (Expenses - \$95,029)**

In late 2016, RAVEN learned that Taseko Mines was appealing the rejection of the proposed "New Prosperity" mine at Teztan Biny (Fish Lake), a pristine and culturally significant place in the heart of Tsilhqot'in territory. This is the third attempt by the company to ram through a polluting mine that would destroy a sacred lake. RAVEN's campaign is ongoing and ramped up in January 2017.

**5. TSLEIL WAUTUTH NATION (TWN) (Expenses - \$42,749)**

RAVEN supported the Tsiel Waututh Nation through preparations for filing a Judicial Review of the proposed Kinder Morgan pipeline. This work planted the seed of a much broader campaign that became RAVEN's second Pull Together campaign in 2017.
